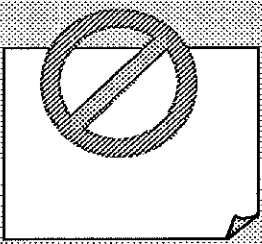
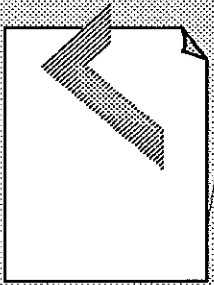
Cyber Security Awareness, Keeping Kids Safe Online



CHECK LIST

Before submitting your artwork, please make sure you meet the following requirements:

- Make sure your name is written clearly on the entry form.
- Avoid using logos and other company trademarks.
- Avoid staples, please. Make sure your name is on the back of the artwork and it matches your name on the submission form.
- Your work must be completed on 11" x 8.5" LANDSCAPE paper, not portrait (ie. turn paper sideways).



The State of West Virginia is participating in the Multi-State Information Sharing and Analysis Center's (MS-ISAC) national K-12 Computer Safety Contest. This contest helps encourage young people to use the Internet safely and securely by crafting messages and images that will best resonate with their peers across the country.

Their artwork should illustrate any original concept that depicts the safe use of the Internet or mobile devices. Topics may include, but are NOT limited to:

- Cyberbullying
- Staying Safe Online
- Avoiding Viruses
- Identity Theft
- Electronic Privacy
- Social Media Safety

Who can participate?

The contest is open to all public, private or home-schooled students in kindergarten through twelfth grade.

What is the process?

The top three winners from the state in each grade group (K-5, 6-8, 9-12) will be submitted to MS-ISAC for entry into the MS-ISAC National Poster Contest.

Winning entries of the National Contest will be included in the MS-ISAC 2018 Calendar, which is distributed to every state in the country as part of the MS-ISAC Cyber Security Awareness Toolkit. Entries received may also

be used in other national, regional and state cyber and computer security awareness campaigns. Prizes are awarded to all state finalists. Every participant will receive a Certification of Participation.
